ORDER:

In the letter 11th read above, the Registrar, Dr. NTR University of Health Sciences has proposed certain modifications to the G.O. 10th read above, for smooth conduct of counseling in fillup of NEET-UG ranking based Management quota seats in Un-aided Minority Educational Institutions.

2. Therefore, in exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (AP Act No.5 of 1983) and in partial modification of the Andhra Pradesh Un-aided Minority Professional Institutions (Regulations of Admissions into Under Graduate Medical and Dental Professional Courses) Rules 2007, issued in G.O.Ms.No.272, Health Medical & Family Welfare (E1) Department, dated. 10.07.2006, as amended subsequently, the Governor of Andhra Pradesh hereby makes the following amendments to the Rules for admission into the Under Graduate Professional Courses in Medical and Dental in Un-aided Minority Professional Institutions in the State.

3. The Government after careful examination have decided to amend the Andhra Pradesh Un-aided Minority Professional Institutions (Regulations of Admissions into Under Graduate Medical and Dental Professional Courses) Rules, 2007 issued in G.O.Ms.No.272, Health Medical & Family Welfare (E1) Department, Dt.10th July, 2006, and as amended subsequently.

4. Accordingly, the following notification shall be published in the Extraordinary issue of the Andhra Pradesh Gazette, Dated:15-07-2019.

NOTIFICATION

In exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (A.P. Act No. 5 of 1983) the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Un - aided Minority Professional Institutions (Regulations of Admissions into Under Graduate Medical and Dental Professional Courses) Rules, 2007 issued in G.O.Ms.No.272, Health Medical & Family Welfare (E1) Department, Dated:10th July, 2006 and published in the Rules supplement to Part-I, Andhra Pradesh Gazette, 12.07.2006.

<u>A M E N D M E N T S</u>

In the said rules,

- **I.** For Rule 6 (B) under III, the following shall be substituted:
- 6. (B) to fill up NEET-UG ranking based Management quota Seats.
 - i. The item vi, : the words " time of counseling " is replaced as " time of verification of certificates and documents".
 - ii. The item vii: the words " shall be called for the counseling" is replaced as " shall attend for verification of certificates and documents as per the counseling process (Web Counselling / offline counseling) notified on University website"
 - iii. In item viii,
 - 1. The **sub rule "b" deleted.**
 - 2. The **Sub rule "c**" is substituted as "The Candidates whose names present in the merit list displayed by the University have to exercise web options / attend for counseling as per the notification issued by the University.
 - 3. The **Sub rule "d & e**" is substituted as " The candidates selected for admission into Un-aided Private Minority Professional Institutions shall get the allotment order by paying the prescribed Non-Refundable University Fee through net banking in case web counseling or immediately at the counseling centre in case of offline counselling.

The selected candidates shall pay the prescribed fee in the form of demand draft drawn on any national bank as notified by the University. If a candidate fails to pay the fee on the day of reporting at the allotted college or at counseling as notified, the selection will be cancelled forthwith and the vacancy will be filled as per the counseling procedure.

- 4. The **Sub rule "f"** is substituted as "Once a candidate secures admission to a particular college / course based on the his / her option in the 1st counseling, such candidate shall be allowed for sliding for admission into other college / course in the 2nd counseling. No more claims to admission into other colleges / course be entertained after 2nd counseling during that academic year.
- 5. The **Sub-rule** "h" is substituted as " The admissions through counseling into management quota seats will be closed after mop-up counseling and the candidates who were admitted will be considered as the bonafide candidates of the respective colleges.
- 6. **Sub rule "j**" is substituted as "All unfilled seats after Mop-up counseling of Category-A in private Un-aided Minority Medical and Dental Colleges will be surrendered to the Convenor of the Committee for admissions constituted by the competent authority i.e. Vice –Chancellor. Such unfilled seats will be treated as Category-B seats and added to the available Category-B vacancies and filled in subsequent counseling for Management quota seats.

If any seats fall vacant after Mop-up counseling (stray vacancies) for Category B & Category C such seats will be surrendered to the Principals of the individual colleges. Such seats shall be filled by the Principals of the individual colleges on merit through NEET-UG ranking from the merit list as per the rules of Government of India / Apex bodies issued in this regard.

- (m) The Competent Authority will notify the penal action for non-joining in the allotted seat and eligibility for further phases of counseling.
- (n) No candidate will be permitted to cancel the seat / withdraw from the course after mop-up counseling until closure of admissions.
- (o) All the admission process will be completed within the schedule notified by the Government of India / Apex bodies. No seat will be filled after closure of admission in any form.
- (p) The Competent Authority shall take necessary steps / penal action to control the blocking of seats by any candidate in the counseling.
- (q) If any candidate wants to withdraw from the course after the closure of admissions in the middle of the course such candidate has to submit the request through the principal of the college concerned along with course discontinuation fee Rs.3,00,000/- for MBBS and Rs.1,00,000/- for BDS course and GST as applicable to the University by way of demand draft.
- (r) The committee for admissions shall examine and resolve the grievances, if any, received from the students on the counseling till the closure of admissions.

II. For **Rule 6 (C) under IV**, the following shall be substituted:

" These seats shall be filled by the Convener of the committee for admissions constituted by the Competent Authority by following the due procedure. All seats shall be filled from the merit list prepared based on NEET ranks.

The Candidate shall submit an affidavit and required documents that he / she is NRI or Children / under guardianship of NRI. Eligibility of NRI candidates for admissions will be as per MCI / DCI rules.

In case Minority candidates are not available for Management Quota seats, the seats can be filled up by Non-Minority candidates in the last phase of counseling. The Non-Minority candidates should not exceed 30% of total seats.
