

PUBLIC NOTICE

(SELECTION PROCEDURE FOR ADMISSION INTO B.Sc(Nursing) – 4 YEAR DEGREE COURSE FROM ACADEMIC YEAR 2023-24 ONWARDS)

It is hereby informed that, the Indian Nursing Council, New Delhi vide Gazette Notification No.275 dated 05.07.2021 has notified for the implementation of REVISED REGULATIONS AND CURRICULUM FOR B.SC. (NURSING)PROGRAM, REGULATIONS, 2020 from the Academic Year 2022-23,wherein it was stated under 'Admission terms and conditions' that the 'Selection of candidates should be based on the merit of the entrance examination conducted by University/State Government.'

The minimum qualifying criteria for entrance test as per the Gazette Notification No.205 of Indian Nursing Council {Revised Regulations and Curriculum for B.Sc.,(Nursing) Program – Corrigendum}, Regulations, 2022 dated 08.04.2022 is as under:

General	- 50th percentile
SC/ST/OBC	- 40th percentile
General-PwD	- 45th percentile
SC/ST/OBC/-PwD	- 40th percentile

Accordingly, the University adopted the following criteria for admission to B.Sc.,(Nursing) course from the Academic year 2023-24 onwards till NEET-Nursing is conducted and to adopt NEET-Nursing as and when it is introduced, duly amending the selection procedure vide G.O. Ms. No.41HM & FW (C2) Dept., dated 15.03.2023 of Government of Andhra Pradesh.

A) Under Competent Authority Quota:

The committee shall make selections based on the rank obtained in Andhra Pradesh EAPCET and other applicable rules till NEET-Nursing is conducted.

B) Under Management Quota:

Selection for Management Quota seats will be made by the management of the college or institution based on the rank obtained either in AP-EAPCET OR NEET-UG and other applicable rules till NEET-Nursing is conducted.

In view of the above the candidates seeking admission to B.Sc.(Nursing) – 4 Year Degree Course from Academic Year 2023-24 onwards in the affiliated B.Sc.(Nursing) Colleges of Dr. Y.S.R. University Health Sciences, Vijayawada are hereby informed as under;

A) Admission under Competent Authority Quota:

Candidates have to appear for the Andhra Pradesh EAPCET(Bi.P.C stream) conducted by the Andhra Pradesh State Council for Higher Education(APSCHE), Mangalagiri, and should secure the minimum qualifying criteria in the Entrance Test as stated above apart from other eligibility criteria prescribed by the INC, New Delhi/Dr. YSR UHS, Vijayawada.

B) Admission under Management Quota:

Candidates have to either appear for the Andhra Pradesh EAPCET(Bi.P.C stream) conducted by the Andhra Pradesh State Council for Higher Education(APSCHE), Mangalagiri or NEET-UG conducted by the National Testing Agency(NTA), New Delhi, and should secure the minimum qualifying criteria in the Entrance Test as stated above apart from other eligibility criteria prescribed by the INC, New Delhi/Dr. YSR UHS, Vijayawada. In deciding the merit between AP-EAPCET and NEET-UG, first priority shall be given to AP-EAPCET, and the second priority shall be given to NEET-UG.

ORDER:-

In the G.O. first read above, Government have framed the rules for grant of permission to B.Sc (Nursing) private colleges and prescribed the procedure for admission of the students.

2. In the letter fifth read above, the Registrar, Dr.YSR University of Health Sciences, Vijayawada, has furnished proposal basing on the revised regulations issued by the Indian Nursing Council, New Delhi and requested the Government to issue amendment to the existing rules from the academic year 2023-24 onwards.

3. The Government after careful examination of the matter, hereby decided to amend the Andhra Pradesh Private Colleges of Nursing (grant of permission to Private Colleges or Institutions and admission into B.Sc. Nursing Course) Rules, 1997 issued in the G.O 1st read above as subsequently amended from time to time.

4. Accordingly, the following Notification shall be published in the next issue of the Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred by Section 99 of the Andhra Pradesh Education Act, 1982 (Act No.1 of 1982), the Government of Andhra Pradesh hereby make the following amendments to the Andhra Pradesh Private Colleges of Nursing (Grant of Permission to Private Colleges or Institutions and admissions into B.Sc Nursing Courses) Rules, 1997 issued in G.O.Ms.No.145, Health Medical & Family Welfare (M2) Department, Dt. 18.05.1998 as subsequently amended from time to time:-

AMENDMENT

In the said rules

1. In rule 5,

(I) for sub-rule (ii), the following shall be substituted, namely;-

“From academic year 2023-24 to adopt the following criteria for admission to B.Sc (Nursing) course from the Academic year 2023-24 onwards till NEET-Nursing is conducted and to adopt NEET - Nursing as and when it is introduced.

Under Competent Authority Quota:

The committee shall make selections based on the rank obtained in Andhra Pradesh EAPCET and other applicable admission criteria as per INC/Dr YSRUHS Regulations, till NEET-Nursing is introduced/conducted.

The minimum qualifying criteria of entrance test to admission to B.Sc (N) is as under:

General - 50th percentile
SC/ST/OBC - 40th percentile
General-PwD - 45th percentile
SC/ST/OBC/-PwD - 40th percentile

NOTE :

Candidates who qualify AP-EAPCET are only eligible for admission into B.Sc (Nursing) 4 Years Degree course from the Academic year 2023-24 onwards till NEET-Nursing is introduced.”

(II) for sub-rule (iii), the following shall be substituted, namely;-

“From academic year 2023-24 to adopt the following criteria for admission to B.Sc (Nursing) course from the Academic year 2023-24 onwards till NEET-Nursing is conducted and to adopt NEET-Nursing as and when it is introduced.

Under Management Quota:

Selection for Management Quota seats will be made by the management of the college or institution based on the rank obtained either in AP-EAPCET OR NEET-UG and other applicable admission criteria as per INC/Dr YSRUHS Regulations till NEET-Nursing is introduced/conducted.

The minimum qualifying criteria of entrance test to admission to B.Sc (N) is as under:

General - 50th percentile
SC/ST/OBC - 40th percentile
General-PwD - 45th percentile
SC/ST/OBC/-PwD -40th percentile

The College management shall prepare the Merit List basing on the rank obtained in the Entrance Test appeared by the candidate. In case of students appearing any one of the two Entrance Tests i.e., AP-EAPCET or NEET- UG, merit list shall be prepared basing the following criteria:

a) First priority shall be given to AP-EAPCET, second priority to NEET-UG."

2. In rule 8, in sub-rule (2) for clause (ii), the following shall be substituted, namely;-

" Age:

The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought. The maximum age limit for admissions shall be 35 years. There shall be relaxation of 3 years in favour of S.C., S.T., and B.C. candidates. The upper age limit shall be relaxed by 5 years for disabled candidates."
