ORDER:

In the letter 3rd read above, the Registrar, Dr. NTR University of Health Sciences, Vijayawada has reported that the Medical Counselling Committee (MCC), Directorate General of Health Services, Govt. of India in its Notice Dt: 22.09.2022, in light of the Hon'ble Supreme Court of India orders in W.P.(C) No. 1397/2020, and quoting the Gazette Notification of Ministry of Home Affairs, Govt. of India vide No. S.O.1050 (E) dated 04/03/2021 stated as under:

"(4) parity with Non-Resident Indians in the matter of- (ii) appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced) or such other tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat: Provided that the OCI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens "

2. The Registrar, Dr. NTR University of Health Sciences has therefore, requested the Government to issue necessary amendments in the matter.
3. The Government after careful examination of the proposal have decided to amend the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Under Graduate Medical and Dental Professional Courses) Rules, 2007.
4. Accordingly, the following notification shall be published in an extraordinary issue of the Andhra Pradesh Gazette dated: 12.10.2022.

NOTIFICATION

In exercise of the powers conferred by Sections 3 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No. 5 of 1983), the Government of Andhra Pradesh hereby makes the following amendment to the Andhra Pradesh Un-aided Non-Minority Professional Institutions (Regulation of Admissions into Under Graduate Medical and Dental Professional Courses) Rules, 2007 issued in G.O.Ms.No.136, HM&FW (E1) Department, dated.30.04.2007 and published in Rules Supplement to Part-I Extraordinary Issue of the Andhra Pradesh Gazette No. 30, dated the 2nd May, 2007 and as subsequently amended from time to time.

AMENDMENT

In rule 3 of the said rules, for clause (a), the following shall be substituted, namely,-

"(a) Nationality and Domicile: The candidates should be Indian Nationals and should satisfy Local, Non-Local status requirement as laid down in the Andhra Pradesh Educational Institutions (Regulation of Admission) Order, 1974 as amended in G.O (P) No. 646 Education (W) department, dated 10.07.1979.

Provided that, Persons of Indian origin (PIO)/ Overseas Citizen of India (OCI) Cardholders are eligible for admission only against any Non-Resident Indian seat or any supernumerary seat;

Provided further that, the OCI Cardholder shall not be eligible for admission against any seat reserved exclusively for Indian Citizens."
