I am by direction to inform that, the Phase-II/Final web based counselling for PG AYUSH {i.e., MD(Homoeo) & MD/MS(Ayurveda)} seats were completed and candidates have to report at the respective PG AYUSH Colleges on or before **03.00 PM on 24-03-2023**. College wise allotted list is placed in the University website <http://drntruhs.in>

In this connection, I am to inform you that, this University has verified the uploaded scanned copies of the candidates for PG AYUSH {i.e., MD(Homoeo) & MD/MS(Ayurveda)} admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a “Committee” consisting of 2 or 3 Professors and Principal as chairman of the Committee shall arrange to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The “Committee” to be constituted at the colleges, is completely responsible for the verification of all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

The list of documents to be verified at the time of admission is specified vide Annexure- I and please follow the instructions given vide Annexure – II.

**Note: Social Status Certificates issued by States other than AP/TS are not considered and should be informed to the University immediately.**

**Instructions: -**

- 1) The candidates who secured their AIQ-PG seats through AACCC – PG Counselling 2022 are not eligible to participate in this counselling as per Ref.L-14030/137/2022-EP-1, dt.13.03.2023 & 17.03.2023. If it is found that the in-eligible candidate participated in this counselling, candidature of such candidate will be cancelled and will not be permitted in further counsellings.
- 2) The selected candidates can download the provisional allotment order on payment of University Registration Fee through payment gateway and report at the allotted college on or before the date specified in the allotment order.
  - a. Candidate who has already joined and now slide to another college is deemed to be relieved from the previous college and who have paid university fee in the Phase-I need not pay again and shall report to the Principal of newly allotted college with the following documents.
    - Allotment letter of Phase-II/Final counseling
    - Custodian certificate issued by the previous college
    - Admission letter issued by the previous college affiliated to Dr. YSR UHS and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission. The candidate also informed to intimate the Principal of earlier college about the allotment in Phase-II/Final
    - counseling through mail/mobile.
  - b. Candidates who are allotted seat in the Phase-II/Final have to download the allotment order from the portal by paying University fee Rs. 10,100/- through payment gateway or net banking and report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
- 3) Date of commencement of classes 10.04.2023.
- 4) The University fee once paid shall not be refunded under any circumstances.
- 5) The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
- 6) **If any not reported seats after PG AYUSH CQ Phase-II/Final, the MOP-UP counselling will be conducted. The candidates who were allotted seat in Phase-I & Phase-II/Final counselling are not permitted for MOP-UP Round.**
- 7) If the candidate slides to other college during Phase-II/Final counselling, the original certificates will be sent to the newly allotted college by the previous college.



- 8) As per G.O. Ms No.13, HM & FW (F2) Dept., dt. 05.02.2021, If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 50000/-+9000/-@18% GST (Rupees Fifty Nine thousand only) in the form of DD drawn in favour of the Registrar, Dr.YSR University of Health Sciences, A.P., Vijayawada.
- 9) After the cutoff date for reporting i.e., by **03.00 PM on 24-03-2023**, no candidate should be admitted and their Provisional admission is deemed to be cancelled without any further intimation.
- 10) Principals have to upload the Report/Not Reported data in the Website [https://pg.ntruhsadmissions.com/principal\\_login/login](https://pg.ntruhsadmissions.com/principal_login/login) by **04.00 PM on 24-03-2023**.
