1	As per G.O.Ms.No.88, HM&FW (E1) Dept., dt.21-05-2014 of Govt. of Andhra Pradesh			
	"After completion of the final Counseling for service seats, the unfilled service seats shall be identified for its original category in the seat matrix of the service seats and shall be added to the non-service seats before commencement of the second counseling for non-service seats".			
2	Candidates who have already joined and continuing in the colleges of Telangana State			
	are not eligible to exercise Web Options in this Phase-II.			
3	Candidates are advised to go through the Prospectus (placed in the University website or 21-07-2023) and the Government Orders on Rules of PG (Medical) admissions available before exercising web options. Candidates are also advised to go through the details about "MRC concept which is exemplified below:			
	Example:			
	a) In a particular college MD(RD) seat is under "Open Category" in the seat matrix and a SC candidate is allotted that Open Category MD(RD) seat in Open Round Counselling of Phase-I as per his/her web options and NEET Rank merit order of the candidate. Now this candidate is shown as Meritorious Reserved Candidate (MRC).			
	b) The same SC candidate has slided to MD (General Medicine) SC category seat in the same college or another college during the Category Round of Phase-I Counselling conducted on the same day , then that MD(RD) seat vacated by this MRC candidate shall be filled with the SC candidates only by merit amongst them.			
	c) This type of MRC concept is to be followed for all BC/SC/ST categories in order to maintain 50 : 50 ratio of Open : Category Reservation			
	d) G.Os governing MRC and other regulations:

4	Candidates opting for PG(Medical) Degree/Diploma courses are informed that, there is no limit of choices (number) for exercising web options. Candidates can exercise any number of options for any number of subjects and colleges if the candidate is interested to join as per eligibility and availability of the PG (Medical) seat.			
5	Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options. Candidates are advised to exercise options in Courses and colleges in which they are really interested. If they are not interested to join any subject or college then they should not exercise options for the same.			
6	Candidate can exercise web options from any place having internet facility One Time Password will be sent to the registered mobile number at the time of saving Web options.			
	 I) Selected Options can be slided either up or down, added and deleted. II) Web options opted must be saved by the candidate. III) Web options once submitted can not be Edited. IV) Web options saved but not submitted until the cut off date and time will be Auto submitted. 			
7	The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the eligibility criteria to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.			
8	The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.			

As per G.O.Ms.No.67, dt.21-04-2017 in the final Phase of final counselling: A candidate who exercised web options and joined in an allotted seat shall not be permitted to withdraw from the seat. In case any candidate withdraws from the allotted seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3,54,000/- (including 18% GST).
