MANAGEMENT (CATEGORY B1, B2 & CATEGORY C (NRI)) QUOTA SEATS
FOR THE ACADEMIC YEAR 2023-24**

In continuation to this Office notification dt.06.10.2023, Dr. YSR UHS, Vijayawada hereby notifies the following schedule for exercising **Web Options for Phase-II** of counselling for admissions into BDS course for the academic year 2023-24 under Management Quota (**CATEGORY B1, B2 & CATEGORY C (NRI) Quota Seats**):

All the candidates whose names are present in the Final Merit Position displayed on 18.08.2023 and its addendum, if any, in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website <https://drysr.uhsap.in>

University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card/Credit Card/Internet Banking/UPI) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

NOTE : Candidates those who allotted in the Phase-I under Management Quota and paid University fee need not pay again.

Tuition Fee:

As per G.O.Ms.No.111 HM & FW, (C1) Department, Dt.24-07-2023, the following is the tuition fee in respect of the Category-B & C seats in Private Un-aided Minority and Non-Minority Dental Colleges in Andhra Pradesh per annum for 4 years.

Instructions to the Candidates:-

1. "Once a candidate secures admission to a particular college / course based on his / her option in the 1st counseling, such candidate shall be allowed for sliding for admission into other college / course in the 2nd counseling. No more claims to admission into other colleges / course be entertained after 2nd counseling during that academic year". (G.O.Ms.No.71, HM&FW (C1) Dept., dated 15.07.2019 & G.O.Ms.No.72, HM&FW(C1) Dept., dated 15.07.2019 of Govt. of Andhra Pradesh).
2. Further, as per the orders dated.22.07.2022 of the Hon'ble Supreme Court of India in Contempt Petition (C) No.289 of 2022, the joined candidates up to round 2 shall not be eligible to participate in the further rounds for State Quota.
3. The candidates who have joined in BDS Course under Management Quota in earlier counsellings of Dr. YSRUHS are also eligible for exercising options in this Phase-II of counselling, if they wish to slide to other college or to another category. The candidates are also eligible to slide from category 'C' to category 'B'.
4. The candidates who have not reported at the allotted college in the 1st phase counselling under the notification dated.06.10.2023, will be allowed to participate in the Phase-II counselling.
5. Candidates are advised to go through the Prospectus / Regulations of Dr. YSR UHS available on website before exercising web options.
6. The number of seats available under this Phase -II counselling is given at Annexure-I.
7. The allotments will be as per merit and prioritised options exercised by the candidates.
8. **Options:**
 - a. The eligible candidates present in the Provisional Final Merit list displayed on 18.08.2023 and its Addendum, if any, should exercise options.
 - b. A candidate has to exercise options for the interested dental colleges in the order of priority.
 - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
 - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - e. Candidates are instructed to take the printout of the saved options.
9. Management Quota B & C (NRI) seats in Minority Dental College will be allotted to Muslim Minority Candidates only. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Mop- up Phase of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Dental Colleges.
10. Candidates will receive the message regarding allotment of seat, if seat is allotted.
11. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
12. Selected candidates have to report to the Principal of the allotted college before the last date and time for joining as specified on the allotment letter with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.

- 13.If the joined candidate of Phase-I slides to other college during Phase-II of counselling, the original certificates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with custodian certificate issued by the previous college under Dr. YSR UHS and to pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
- 14.Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
- 15.**Next phase for Mop-up counselling (exercising web options) will be conducted for:**
- Unfilled seats in Phase – 2.
 - Not reported / Not joined seats after Phase-2.
16. Allotted candidates in earlier phases i.e. Phase-I or Phase-II of Competent Authority Quota / Management Quota are not eligible for Mop-up round counselling to prevent seat blocking.
- 17.The University fee once paid shall not be refunded under any circumstances.
- 18.As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions, in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee of Rs.1,00,000/- for BDS plus GST as applicable to the University by way of demand draft drawn in favour of the Registrar, Dr. YSR University of Health Sciences, payable at Vijayawada.
- Note:**The requests received directly from the candidates for withdrawal from BDS course will not be entertained under any circumstances. Any request shall be routed through Principal concerned only as per the G.O.Ms.No.72, HM & FW (C1) Dept, dated.15-07-2019.
- 19.Decision of Competent Authority is final.
20. Dr.YSR University of Health Sciences does not entertain or support seat blocking/ cancellation of BDS seats.
- 21.In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
