**Instructions to Candidates:**

1. Vacancy position is displayed on University website for information to the students to exercise their options.
2. Fresh options will be obtained from all the eligible candidates.
3. Phase-I seats vacated because of sliding to other colleges during the course of Phase-II/Final counselling will be added and allotted simultaneously to the next candidates as per the Merit and Rules
4. The following are the vacancies available for CQ Phase-II/Final Counselling

5. Candidate can give options on the website.
6. A candidate can exercise any number of options. The students have to opt clearly for the course in which they are desirous to join.
7. Conversions will be conducted in this Final/Phase-II counseling for filling up of the unfilled vacancies if any as per the rules.
8. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
9. Candidates will receive the allotment order after allotment of seat, if seat is allotted. The candidates are also instructed to visit the [websites:](#)

10. Candidate can download the provisional allotment order on payment of University Fee through payment gateway. The students can login and view the college wise list of selected candidates in the website.
11. Candidates are informed to check their final allotment, take printout of allotment letter from the web and report to the respective colleges on or before the date specified on the allotment letter with all original certificates and pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
12. The verification of original certificates will be conducted at the time of admission in the respective college and in case of any discrepancy, the Provisional allotment will be cancelled. If the candidate slides to other college (i.e., affiliated colleges of Dr.YSR UHS) during subsequent Phases of counsellings, the original certificates shall be sent to the college concerned by the previous allotted colleges.
13. The candidates who secured admission in the Phase-I of counselling and wish to change their college/course according to their merit, can exercise their web options for Phase-II. Candidates informed that once M.Sc(N) & MPT seat is allotted in this counselling as per their web options, the seat allotted in the earlier counselling gets automatically cancelled and will be Re-allotted to other candidates.
14. Students who have already paid the University fee in Phase-I need not pay again if seat is allotted in Phase-II/Final, but should download the allotted order if there is a change in Phase-II
15. The University fee once paid shall not be refunded under any circumstances.
16. **Next phase of counselling will be the MOP-UP Round counselling. The candidates who were allotted seat in Phase-I & Phase-II/Final counselling are not permitted for MOP-UP Round.**
17. **If any candidate wish to discontinue their course, after closure of the admission (or) during the course of period should pay of Rs. 25000/-+4500/- @18% GST (Rupees Twenty Nine Thousand Five Hundred only) in the form of DD drawn in favour of the Registrar, Dr.YSR University of Health Sciences, A.P., Vijayawada.**
