NOTIFICATION FOR EXERCISING WEB OPTIONS FOR MOP UP ROUND OF COUNSELING FOR THE VACANT SEATS OF POST-GRADUATE DENTAL COURSES UNDER Dr. YSR UHS FOR COMPETENT AUTHORITY QUOTA (CQ) SEATS IN GOVERNMENT AND PRIVATE NON-MINORITY DENTAL COLLEGES FOR THE ACADEMIC YEAR 2023-24.

- 1. Eligible **Non-Service candidates** whose names are in the Final Merit Position notified in the University Website are only eligible to exercise web options as per the above dates (Website: <u>https://drysr.uhsap.in</u>)
- 2. Candidates who have not been allotted any seat in any earlier phases of CQ counselling **are eligible** to exercise web options for PG Dental Courses.

#### Eligibility/Not Eligibility for this Mop Up round:

- 1. Candidates who have exercised/participated for web options in earlier Phases of CQ seats but not allotted any seat are eligible for Mop Up round.
- 2. Candidates who have not exercised/participated for web options in any phase of CQ seats are not eligible for participating in Mop Up round.
- 3. Candidates who have been allotted any seat in any Phase of counselling of CQ seats are not eligible to participate in the MoP Up Round.
- 4. Candidates who have already joined/continuing any seat in any Dental college are not eligible to participate in MoP Up Round.
- 5. Candidates who have discontinued the course after joining in any phase of Competent Authority Quota Seats are **not eligible.**
- 6. Allotted Candidates of Stray round of All India Quota (AIQ)/Stray round of KNR UHS, TS are not eligible.
- 7. <u>IMPORTANT NOTE</u>: Candidates if allotted any seat in this MOP UP Round should compulsorily join the course and they will not be permitted to withdraw from the course. As such they are advised to give options to the courses for which they are really interested to join so as to give chance to next meritorious candidates.
- 8. Vacancy position i.e., Un-filled and Not reported seats are displayed in the University website. Hence, the candidates are therefore advised to exercise options for all the seats in all the colleges as per their priority.

- 9. Candidate can download the provisional allotment order on payment of University fee of Rs.23,600/- through payment gateway and report to the Principal of the allotted College on (or) before the date specified in the allotment order.
- 10. The University fee once paid shall not be refunded under any circumstances.
- 11. **TUITION FEE FOR PG DENTAL**: The following is the **Tuition fee structure** for the academic year 2023-24 to be payable for the Competent Authority Quota seats in Private Un-aided Dental Colleges as per G.O.Ms.No.123, HM & FW (C1) Department, dated 10-08-2023 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.
