NOTICE TO THE CANDIDATES FOR MOP-UP ROUND COUNSELLING FOR ADMISSION INTO MBBS
COURSE UNDER COMPETENT AUTHORITY QUOTA FOR THE YEAR 2023-24

1. The counseling will be conducted for the following vacancies (except NCC category seats) which are available due to non-joining of allotted candidates in Phase – II.

Note: a) The seats reserved for NCC category will be filled after receipt of final priority list received from the NCC Directorate.

b) The allotted candidates upto Mop-up round counseling of Dr. YSRUHS under this Phase will not be permitted to upgrade in Special Category counseling of NCC quota.

2. **The candidates who are in the Provisional Final Merit list and subsequent Addendum & Corrigendum, if any, under Competent Authority Quota, already exercised onetime web options and NOT ALLOTTED MBBS SEAT IN EARLIER PHASES OF COUNSELING ARE ONLY ELIGIBLE.**
3. **The candidates who were allotted seats in Phase-I or Phase - II counseling both under Competent Authority Quota and Management Quota and Self-financing / NRI quota (both reported and not reported candidates) are not eligible for this Mop-up round.**
4. The candidates joined upto round-3 under All India Quota and found in the list shared by Medical Counselling Committee (MCC), DGHS, New Delhi are not eligible for Mop-up round counselling under Dr. YSR UHS.
5. The candidates joined into MBBS course, 2023-24 upto Mop-up round counselling of KNR University of Health Sciences, Telangana are not eligible for Mop-up round counselling under Dr. YSR UHS.
6. The seats under Competent Authority Quota available for mop-up round counselling (List of not reported candidates after Phase-II counselling) is placed in the University website.
7. The candidates are instructed to visit the website: <https://ugcq.ylsruhs.com> for status of allotment and downloading the order.
8. Candidate can download the provisional allotment order on payment of University Fee Rs.10,600/- through payment gateway. The students can login and view the college wise list of selected candidates in the website.
9. Candidates are informed to check their final allotment on website and take the printout of allotment letter from the portal and report to the respective colleges on or before the date specified on the Provisional allotment letter, Pay the tuition fee to complete the admission process, failing which the candidate will lose the admission.
10. Candidates who are allotted seat in the mop-up round counseling have to report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
11. Any candidate allotted a seat in this Phase and does not join, he/she will not be eligible for further rounds as per G.O.Ms.No.151, HM & FW (C1) Dept, dated.04.12.2020.
12. The original certificates will be verified at the college and in case of any discrepancy the provisional allotment will be cancelled and action will be initiated as per University regulations.
13. The University fee once paid shall not be refunded under any circumstances.
14. **No candidate is permitted to withdraw from the course till closure of the admissions.**
15. As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions, in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee of Rs.3,00,000/- for MBBS plus GST as applicable to the University by way of demand draft drawn in favour of the Registrar, Dr. YSR University of Health Sciences, payable at Vijayawada.
- Note:** The requests received directly from the candidates for withdrawal from MBBS course will not be entertained under any circumstances. Any request shall be routed through Principal concerned only as per the G.O.Ms.No.72, HM & FW (C1) Dept, dated.15-07-2019.
