ELIGIBILITY for B.Sc., (Nursing) 4 Years Degree Course:

- 1. The minimum age for admission shall be 17 years on 31st December of the year in which admission is sought.
- 2. Minimum Educational Qualifications:
 - a. 10+2 Passed with Science (Physics, Chemistry and Biology) and English is compulsory subject.
 - b. 10+2 passed out from recognized board under AISSCE/ CBSE/ ICSE/SSCE/ HSCE/NIOS/APOSS or other equivalent Board with Physics, Chemistry and Biology.
 - c. Intermediate Vocational with Bridge Course in Biological and Physical Sciences.
 - d. OC candidates should have secured 45% aggregate of marks in Science Subjects, 40% in case of SC, ST and BC candidates. English is compulsory subject as per orders of the Secretary Indian Nursing Council, New Delhi vide letter No.F.No.1-2/2014-INC and vide the circular No. F.NO.1-6/2016-INC, Dated.21-09-2016.
- 3. Students shall be medically fit.
- 4. Students shall be admitted once in a year (As per the G.O.Rt.No.1095, Health Medical and Family Welfare (K1) Depart., dated.02.09.2013)

ELIGIBILITY for Bachelor of Physiotherapy (BPT) Course:

Passed Intermediate (10+2) or equivalent with Botany, Zoology, Physics and Chemistry or Inter vocational with Bridge course of Biological and Physical Sciences or APOSS with Biological and Physical Sciences and should have completed 17 years as on 31.12.2019.

ELIGIBILITY for B.Sc. (Paramedical Technology) Courses:

Passed Intermediate (10+2) or equivalent with Botany, Zoology, Physics and Chemistry or Inter vocational with Bridge course of Biological and Physical Sciences (or) APOSS with Biological Sciences and Physical Sciences and should have completed 17 years as on <u>31.12.2019</u>.

ELIGIBILITY for Post Basic BSc (Nursing) 2Years Degree Course:

The candidates should be of Indian Nationals or Persons of Indian Origin (P.I.O)/Overseas citizen of India (OCI) card holders or Foreign Nationals. The P.I.Os, OCI Card holders and Foreign Nationals shall submit No Objection certificates from Nursing Council of India for admission into Post Basic BSc(N) 2YD Course.

Male and female Candidates are eligible for admission into Post BSc(Nursing 2Years courses as per 228th EC resolution dated 05-05-2018.

Educational Qualifications:

should have passed Intermediate Examination. OR

Any other equivalent examination(10+2 pattern) recognized by the University in A.P. or Board of Intermediate Education Andhra Pradesh or NIOS or APOSS – As per Indian Nursing Council Regulations.

And

Should have passed General Nursing and Midwifery from an institution recognized by the Govt. of A.P. or Nursing Council of India and shall be registered with the State Nursing Council.

(Eligibility Criteria is as per G.O.Ms. No.269 & FW(K2) Dept., Dt.30-11-2009 as amended in G.O.Ms.No.194, HM & FW(K2) Dept., Dt.07-07-2011, Ms.No.40,HM & FW(K2) Dept., Dt.18-02-2012 and G.O.Ms.No.33, HM & FW(K1) Dept., Dt.05-03-2013 and from time to time.

NOTE: The Candidates who studied 1½ Year MPHW are not eligible for admission into Post Basic BSc(Nursing) 2Years Degree Course.

NOTE: The University has decided that, the eligibility for admission into Bachelor of Science in Nursing 4YDC (BSc(Nursing)), Bachelor of Physiotherapy (BPT), Bachelor of Science in Paramedical Technology Courses (BSc Paramedical) shall be based on the marks scored in Science Subjects (PCB) in the Intermediate Board Examination or its equivalent Examination. Further, the mandatory appearance for the EAMCET Examination has been ruled-out from the present prescribed guidelines for admission into the above Courses.

Registration and Verification Fee:

Rs.2360/-(Incl.18% GST) for OC candidates and Rs.1888/-(Incl.18%GST) for BC/ SC/ST candidates

The candidates are informed to take the print-out of application after payment of Registration and Verification Fee at the Payment Gateway during submission of online application.

Candidates have to attend with the printout of application form along with all original certificates and 3 sets of Xerox

Merit List for the above courses will be displayed on the website of the University after verification of the original certificates at Helpline Centers notified.
