NOTIFICATION FOR MOPUP ROUND COUNSELING UNDER COMPETENT AUTHORITY QUOTA

Notification for exercising web options for MOPUP Round for BAMS/BHMS/BUMS and BNYS course counseling for vacant seats arose after Final Phase of Counseling in Government, Private unaided Non-Minority, Aided Ayush colleges for the academic year 2019-20 under Dr.NTR UHS, Vijayawada in the State of Andhra Pradesh.

In view of representations of certain candidates to consider them for sliding from one course to another course and one college to another college in MOPUP round in the vacancies arose after 2nd & Final phase of counseling, as there are different courses in UG Ayush courses. Hence in continuation of earlier notification dated 27.09.2019, and in consideration of the request of the candidates, the University hereby notify the MOPUP Round of web based counseling for BAMS/BHMS/BUMS & BNYS in Government, Private Un-Aided Non-Minority, Aided AYUSH Colleges for the year 2019-20 in the State of Andhra Pradesh seats available under Competent Authority Quota.

List of vacant seats (Not reported) is displayed in the website https://ntruhs.ap.nic.in/ and https://bahnu.apntruhs.in on 05.10.2019.

The candidates whose names are present in the Final Merit List displayed after verification of Original Certificates and the candidates who applied for MOPUP round counseling are eligible to exercise web options. All the eligible candidates can exercise their web options from 9.00 A.M on 06.10.2019 to 2.00 P.M on 07.10.2019 in the website http://bahnu.apntruhs.in.

The candidates who secured admission in earlier counselings wish to change their college/course according to their merit, those candidates who have not joined in the allotted college in 1st phase and those who have not opted/ not allotted seat in the 1st phase can also exercise their web options.

If the candidate is satisfied with the seat already joined he/she need not exercise web options.

The candidates who were admitted in BAMS/BHMS/BUMS & BNYS Courses under AIQ Counseling conducted by Ministry of Ayush, New Delhi or in other state counseling including Telangana State are not eligible to participate in the MOPUP Round Counseling. If any candidate violates this and noticed by the University at any stage during the BAMS/BHMS/BUMS & BNYS courses, such candidate is liable for punishment including cancellation of his/her admission.

The candidates who got allotment in this Phase of Counseling should join compulsorily in the allotted college.

No candidate will be permitted to cancel the seat/ withdraw from the BAMS/BHMS/BUMS & BNYS courses after MOPUP Round Counseling.

The seat allocation will be done as per the Procedure given in G.O.P.No.646, Education (w) dept. Dt.10-07-1979 as amended in G.O.Ms.No.42, Higher Education dept., Dt.18-05-2009 and selection procedure will be made as per orders issued in G.O.Ms No.111 Higher Education (EC) Dept. dt.13.08.2019 & as amended by the Govt. from time to time.

University Fee: Rs 8,500/- for BAMS/BHMS/BUMS/BNYS Courses. The selected

candidates have to pay University fee through payment Gateway by using Online payment method. (Debit Card / Credit Card /

Internet Banking) for downloading the allotment order.

Tuition Fee: The selected candidates have to pay tuition fee for admission into

BAMS/BHMS/ BUMS/BNYS Courses as per orders of Government

Instructions to Candidates:

1. List of not reported candidates is displayed in the University Website http://ntruhs.ap.nic.in

- 2. The detailed instructions for entering options on web are available at http://bahnu.apntruhs.in
- 3. Candidate can give options on the web either from home or any other place having internet facility

One Time Password will be sent to the registered mobile at the time of saving Web options.

The password consists of SIX letter code with English capitals A to Z.

- 4. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
- 5. Candidates are instructed to exercise in the course/courses if they are really interested. The candidates who are not willing to join in college/course, they are directed not to exercise option and give chance to another willing candidate instead of blocking the seat.
- 6. Candidates can download the provisional allotment order on payment of University Fee through payment gateway and report to the Principal of the allotted College on or before the date specified in the allotment order. The candidates who have paid University fee in the earlier phase for downloading the allotment orders need not pay again.
- 7. Candidates are informed to check their final allotment, take printout of allotment letter from the web, and report to the respective colleges on or before the date furnished on the allotment letter, failing which the candidate will lose the admission.
- 8. Selected candidates have to report at the respective colleges on the dates specified on the allotment letter with all original certificates and pay the college fee to complete the admission process. If the candidate slides to other college during subsequent phases of counseling, the original certificates will be sent to the college concerned after the closure of admissions.

9. The University fee once paid shall not be refunded under any circumstances.
