Notification for exercising web options for 2nd Phase of web based counseling for admission into MBBS/BDS Courses under Competent Authority Quota Seats for the academic year 2019-20.

In continuation of earlier notifications dated 21.06.2019, 01.07.2019 and 07.07.2019 the University hereby notify the 2nd Phase of web counseling for the MBBS/BDS seats available under Competent Authority Quota seats i.e., Unfilled, Not Joined Vacant Seats of Dr.NTR UHS, Vijayawada in Government, Private Un-aided Non-Minority & Minority Medical and Dental colleges (under Dr. NTR UHS) and MBBS Seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati for the academic year 2019-20 in the state of Andhra Pradesh.

The seats reserved under special categories i.e., NCC, CAP and Sports & Games will be filled in the next phase of web counselling after display of priority list on the University website.

All the eligible candidates who have got verified their certificates can exercise their options at <http://apmedadm.apntruhs.in> as per the seat matrix displayed in the website <https://ntruhs.ap.nic.in> / and <http://apmedadm.apntruhs.in>.

The candidates, who secured admission in 1st Phase of counseling and wish to change their college/course according to their merit, can exercise their web options. The candidates who are not joined in the colleges allotted in 1st Phase of counseling can also exercise web options in the 2nd Phase of counseling.

The seat allocation will be done as per the procedure given in G.O.P.No.646, Education (w) Department, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education Department, dated. 18.05.2009.

University Fee: Rs.10,500/- for both MBBS and BDS Courses. The selected candidates have to pay University fee through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking) in the state of Andhra Pradesh for downloading the allotment order.

Tuition Fee: Rs.12,155/- as per G.O.Ms.No.30 & 31, HM & FW., (C1) Department, dated 17.04.2015 of the Government of Andhra Pradesh for Government, Private Un-aided Non-Minority, and Private Un-aided Minority Medical and Dental Colleges.

Candidates selected for Sri Padmavathi Medical College for Women, Tirupati have to visit SVIMS website <http://svimspts.ap.nic.in> for tuition fee and other fee details to be paid at College.

Candidates while giving options should note that:

1. On allotment of a seat in this counseling as per the options, the earlier seat where the candidate joined and continuing the course will be added and allotted simultaneously during this counseling.
2. The allotted seat in first counseling will be cancelled automatically on allotment of seat in this counseling as per their option.

The details of vacant seats available will be placed in the University website on 16.07.2019.

1. If a selected candidate in 2nd counseling wants to cancel his/her selection, before reporting in the college, he / she shall apply in writing to the University within the stipulated time specified in the allotment order. In case reported in the college, his /her withdrawal letter should reach the University through the Principal of concerned college before release of 3rd Phase Counseling.
2. The vacancies arose after 2nd counseling will be filled in the subsequent counseling.

Instructions to the Candidates:

1. The candidates can exercise web options through <http://apmedadm.apntruhs.in> using Internet explorer 11 version
2. The candidates who have not exercised web options in previous phase are also eligible to exercise web options.
3. Candidates can exercise options for MBBS/BDS courses in all the colleges in which they are really interested to join irrespective of Vacancies displayed, so as to give chance to next meritorious candidates as per the priority. There is no limit to the number of options.
4. One Time Password will be sent to the registered mobile at the time of saving Web options.
The password consists of SIX letter code with English capitals A to Z.
5. Candidates are instructed to take a printout of saved options
6. Candidates will receive the message on their registered mobile after allotment of seat, if allotted.
7. Candidate can download the provisional allotment order on payment of University Fee through payment gateway and report to the Principal of the allotted college on or before the date specified in the allotment order. However the candidates already paid University fee need not pay again.

8. Candidates have to take printout of allotment order, check their allotment and report to the Principal of respective college before the date specified on the allotment letter.
9. The Candidates who were already allotted a seat in any college of AP and joined, now slided to another college in AP should submit the tuition fee receipt at the newly allotted college for admission. The first college where the candidate initially joined will transfer the fee to subsequently allotted college in AP.
10. **The University fee once paid shall not be refunded under any circumstances.**
