



## **Dr. NTR UNIVERSITY OF HEALTH SCIENCES: ANDHRA PRADESH: VJA – 8**

**Notification for exercising web options for Final Phase of web based counseling for admission into MBBS/BDS Courses under Competent Authority Quota including EWSs and Special Category Seats in Government, Private Un-aided Non-Minority, Minority Medical and Dental colleges (under Dr. NTR UHS) and MBBS Seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati for the academic year 2019-20**

In continuation of earlier notifications dated 07.07.2019 and 15.07.2019 the University hereby notify that Final Phase of web based counseling for the MBBS/BDS seats available under Competent Authority Quota as per the details and schedule given below:

### **Details of Seats:**

The Unfilled seats of earlier counselling, Vacancies arising due to not joining, reverted seats from All India Quota, EWSs seats, Special Category seats i.e. NCC, CAP and Sports & Games and vacancies arising during the process of counseling.

It is to be noted that the seats reserved for Sports & Games will be filled after receipt of Final Priority list from the SAAP Authorities and Displayed the same (merit list) in the University Website. However, the candidates should exercise their options in this phase of counselling itself as per the seat matrix.

### **Schedule:**

All the eligible candidates who have got their certificates verified can exercise their options **from 8.00 AM on 18.08.2019 to 1.00 PM on 20.08.2019** at <http://apmedadm.apntruhs.in> as per the vacancies displayed on 17.8.2019 in the website <https://ntruhs.ap.nic.in> / and <http://apmedadm.apntruhs.in>.

The candidates, who secured admission in earlier phases of counseling and wish to change their college/course according to their merit, those candidates who have not joined in the allotted college in earlier phases and those who have not opted/ not allotted in the earlier phases can exercise their web options.

**The candidates who got allotment in the Final Phase of Counseling should join compulsorily in the allotted college.**

The candidates who were admitted under AIQ Counseling are not eligible to participate in the State Quota Counseling. If any candidate violates this and noticed by the University at any stage during the course of MBBS/BDS such candidate is liable for punishment including cancellation of the seat.

The seat allocation will be done as per the procedure given in G.O.P.No.646, Education (w) Department, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education Department, dated: 18.05.2009.

**University Fee:** Rs.10,500/- for both MBBS and BDS Courses. The selected candidates have to pay University fee through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking) in the state of Andhra Pradesh for downloading the allotment order.

**Tuition Fee:** Rs.10,000/- in Government Medical / Dental Colleges.  
**Rs.12,155/-** as per G.O.Ms.No.30 & 31, HM & FW., (C1) Department, dated 17.04.2015 of the Government of Andhra Pradesh for Government, Private Un-aided Non-Minority and Private Un-aided Minority Medical and Dental Colleges.

Candidates selected for Sri Padmavathi Medical College for Women, Tirupati have to visit SVIMS website <http://svimspts.ap.nic.in> for tuition fee and other fee details to be paid at College.

Candidates while giving options should note that the seats vacated by the candidates on sliding to other college / course during the process of counselling will be added & allotted simultaneously in this phase of counseling. **On allotment of a seat in this phase of counseling, the seat allotted in the previous counselling stands cancelled automatically.**

The vacancies arose after Final Phase of counseling will be filled during the MOP-UP round of counseling. **Candidates who were allotted seats in any phase of counseling are not eligible for Mop-up round counseling.** After MOP-UP counseling, the candidates will not be permitted to cancel selection/seat.

#### **Instructions to the Candidates:**

1. The candidates can exercise web options through <http://apmedadm.apntruhs.in/> using Internet explorer 11 version
2. The candidates who have not exercised web options in previous phases are also eligible to exercise web options.
3. Candidates can exercise options for MBBS course in all the colleges in which they are interested to join **irrespective of Vacancies displayed**, so as to give chance to next meritorious candidates as per the priority. There is no limit to the number of options.
4. **Candidates are not permitted to discontinue the MBBS course after the Final Phase of Counseling notification is issued i.e., from 17.08.2019 to till closure of admissions.**
5. One Time Password will be sent to the registered mobile at the time of saving Web options.  
The password consists of Six letter code with English capitals A to Z.
6. Candidates are instructed to take a printout of saved options
7. Candidates will receive the message on their registered mobile after allotment of seat, if allotted.
8. Candidates have to download the allotment letter by paying the University fee by gateway method (as detailed in the earlier notification dated **07.07.2019**).  
The candidates who have paid University fee in the earlier phases for downloading the allotment orders need not pay again.

9. Candidates have to take printout of allotment order, check their allotment and report to the Principal of respective college before the date specified on the allotment letter.
10. **The University fee and other fees once paid shall not be refunded under any circumstances.**
