- b) Copy of BUMS Degree Certificates (Attested Xerox copy only).
- c) The candidates who are from outside the State appearing for the University examination for the first time should submit their migration certificate.
- d) Attendance certificate in the prescribed proforma and testimonials from 2 (Two) faculty members.
- e) Copy of Part-I marks Sheet incase of Part-I failed candidates & also P-II appearing candidates.
- f) These candidates should have submitted dissertations within the time schedule fixed by the University as already notified.

The academic year of admission, date of admission and particulars of previous appearance, if any, shall be noted in the application.

Note: Hall Tickets to the candidates of MD(Unani) Part- II will be issued only, if their dissertations are approved.


