The Notification is issued for registration of candidates to appear for Super Speciality Supplementary theory Examinations scheduled from 19.06.2024.

ELIGIBILITY TO APPEAR FOR SUPER SPECIALTY EXAMINATIONS:

- 1. The Super Speciality students who have admitted in the medical colleges affiliated to Dr. YSR UHS, Andhra Pradesh State, whose admissions are approved by the YSR UHS during the academic year 2020-21 and the students who were failed, detained and not registered for Super Speciality examinations conducted earlier are eligible to appear examinations to be held in the month of June, 2024.
- 2. The students should put in Academic Year wise compulsory attendance of 80% i.e, must put in 292 working days in each year. The Students whose study period completes by 31.05.2024 are only eligible to appear for June, 2024 Super Specialty exams. Hence, the Principals are directed to verify the cut of date before sending the ICR forms to the University.
- **3.** Dissertations of Super Speciality Students should be approved by two external examiners and one internal examiner to get eligibility to appear for examinations. Hall Tickets will not be issued to those students whose dissertations are not approved.
- **4.** The study period (duration of course) of the candidates is extendable in cases of Medical Leave / Maternity Leave / Any Other Leave / Absence beyond 30 days in each year.

- 5. The attendance certificate in respect of each candidate duly signed by the HOD and counter-signed by the Principal indicating the Academic Year / Batch of Admission, Date of Admission (Date of Joining), Details of leaves availed, Total number of leave days availed, Year-wise percentage of attendance, Date of completion of study period must be furnished in the prescribed standard proforma along with the filled-in ICR Forms. A model copy of the attendance certificate is enclosed herewith. No other format is to be used.
- **6.** Thesis submission certificate is also to be enclosed. The candidates of Super Speciality Examination must submit two testimonial certificates duly issued by two Professors, separately, in the prescribed standard proforma duly enclosed.
- 7. Completion of Online Course in Research Methodology is mandatory for publication of results and the candidates should submit Online Course in Research Methodology completion certificate.
- 8. As per National Medical Commission (Medical Council of India) Regulations (Amended up to June, 2017) the following sub – clause is added after clause 13.8(c) in terms of Gazette Notification dated 09.12.2009 and the same is under.
 - "A postgraduate student of a postgraduate degree course in broad specialties/Super Specialties would be required to present one poster presentation, to read one paper at a national/state conference and to present one research paper which should be published/accepted for publication/sent for publication during the period of his postgraduate studies so as to make him eligible to appear at the postgraduate degree examinations."
- 9. As per Lr.No.MCI 23(1)/2014/Med./157716, Dt: 11.04.2015, National Medical Commission (Medical Council of India) has informed as follows:
- > The Academic Committee recommended that the students are required to pass theory and practical examinations separately in terms of the governing provisions pertaining to the scheme of examination in the PG Regulations and recommended that an examinee should obtain minimum 40% marks in each theory paper and not less than 50% marks cumulatively in all the four papers for Degree examinations to be cleared "passed" at the said degree examination as the case may be."

Hence, in view of the above NMC (MCI) Regulations, the minimum pass marks in theory is as follows:

- a) 40% marks in each paper separately i.e., 40/100
- b) 50% marks cumulatively in all the four papers for degree exam and three papers in diploma exam i.e., Degree Exam 200/400 Diploma Exam 150/300.
- c) Super Speciality Practical/Clinical marks 300 & Viva Voce marks 100 passing minimum for Practical / Clinical including Viva voce 200/400.
- 10. The University is implementing Digital Valuation in Super Specialty exams from July, 2019 onwards.

In view of introduction of Digital Valuation in Super Specialty exams. A single <u>68 pages</u> OMR answer book <u>with 64 writable</u> pages will be issued to the candidates appearing for June, 2024 examinations and no additional answer book will be issued to the candidates. The candidates should answer all the questions in the single answer book of <u>64 writable</u> pages only.

Further it is to inform that the Digital (ONLINE) Valuation will be done with 4 examiners i.e., two internal and two external examiners as per the Orders of the Hon'ble High Court of Andhra Pradesh & Telangana in WP.No.24394 of 2017 and Other Batch Cases in PG Degree/Diploma Courses. The same was implemented in Super Specialty from July, 2019 Examinations.

Note: Hall Tickets to the candidates for Super Speciality will be issued only <u>if their</u> dissertations are approved.

- V. Therefore, the Principals are advised to collect and remit the Examinations fee through online payment mode at https://drysr.uhsap.in/epay/ by 18.05.2024 and send the same to the University along with exam material (student details, fee, attendance statement, freezed copy etc.) and printout of data which is uploaded in Medhas Portal to reach by 20.05.2024.

INSTURCTIONS TO THE PRINCIPALS:

- 1. The Principals are informed to verify the eligibility of the students before submitting the data on the Portal.
- 2. If any ineligible student details furnished on the Medhas Portal, the Principal is solely held responsible for that.

The following copies of certificates shall be enclosed by the candidates along with the application.

- a) Two Testimonials from any two Lecturers of the college concerned.
- b) Attendance Certificate from the Principal
- c) Copy of PG Original Degree (Attested Xerox copy only).
- d) A copy of Poster Presentation and research paper published.
- e) Completion of Course certificate in Research Methodology.

Unless these certificates are enclosed with the application, the application will not be considered and there will not be any further correspondence with the candidate.

The students are informed that ICR Forms are being sent. Hence, to fill the forms and they have to follow the instructions given in 2nd page of the ICR Forms. The name must be written exactly as spelt in the PG Degree Permanent Certificate, without fail. They have to enclose (i) Dissertation submission Certificate; (ii) Attested copies of their MBBS and PG Degree Permanent Certificates; (iii) Two separate Testimonial Certificates issued by two faculty members (iv) Attendance Certificate duly signed by the HODs and Counter-Signed by the Principals giving the particulars viz., Academic Year / Batch of Admission, Date of Admission (date of joining), Details of leaves availed, Total number of leave days availed, Year-Wise percentage of attendance, Date of completion of the study period course etc., (A model copy of the Attendance Certificate is enclosed herewith. No other format is to be used).

The referred candidates have to enclose a copy of their previous Exam's Hall Ticket and also copies of their MBBS and PG Degree permanent certificates once again without fail.

The Principal (or person authorized by the Principal) have to sign in the **ICR Form**.

Necessary details for requirement of temporary Advance for conducting theory/practical exams. It must be noted that if the previously sanctioned temporary advance has not yet been settled, no fresh Advance sanction shall be accorded.

Further it is to inform that as per the Judgment dated 04.11.2022 in Civil Appeal No 8037/2022 which Civil Appeal No. 8038/2022 of Hon'ble Supreme Court of India, New Delhi there is no provision for revaluation of answer scripts and the procedure adopted by the University in digital evaluation of answer scripts is upheld by the Apex Court.
