Sub:- Dr. YSR UHS – Exams – Conduct of PG Degree Regular Examinations in May, 2024 – Calling for submission of Dissertations CD's for evaluation for the candidates admitted in PG Degree with One Year Exemption (Those who have completed PG Diploma course) for the academic year 2021-22 – Notification – Issued – Regarding.

I am to inform that, the Regular theory examinations for PG Degree Courses for the Academic Year **2021-22** to those candidates admitted in PG Degree with One Year Exemption are scheduled to be held in the month of May, 2024. Hence, the following guidelines and instructions should be followed in submitting Dissertations which are to be sent for Evaluation by the examiners.

1. The University has introduced **Plagiarism Software** for PG Dissertations. Hence the **students shall check dissertations with Plagiarism M/s. Drillbit Softtech India Pvt. Ltd, Bangalore and submit the Plagiarism certificate** to that effect along with Dissertation CDs duly signed by concerned HOD and have to submit three copies of the Dissertations Soft Copy (CDs) to the University as per the dates mentioned below for forwarding to the External Examiners for Evaluation. The following is the fee particulars.
 - (a) The **Last date** for receipt of the Dissertation soft copies (CD's) to the University is **20.01.2024** with a fee of **Rs.3,000/-**
2. **Therefore, the Principals are advised to collect and remit the Dissertation fee from the college official account (and not individually), to the University Account No. 110035227082 of Canara Bank, Siddhartha Medical College Branch, Vijayawada and IFSC Code is CNRB0013366.**
3. The Principals are informed to direct the candidates to submit the **dissertations CD's in PDF format only for convenience to open and evaluate by the examiners easily.**
4. The students have to submit two more copies of the Dissertation which are to be retained by the respective HOD's / College Offices for evaluation by the concerned Internal Examiners.
5. **The Referred candidates those who have earlier submitted their Dissertation soft copies 3 (CD's) need not submit for this examination.**
6. No Dissertation soft copy will be accepted by this University after the last dates as specified above. The Principals are requested to arrange to send Dissertation soft copies to the University Office as per the above schedule.

7. Dissertation received after the above specified dates will not be accepted. **As per PG Regulations the candidate will not be permitted for May, 2024 examinations if dissertation are not approved by the examiners.**
8. This should be brought to the notice of all the concerned students and faculty concerned immediately.
9. Dissertation with soft copy (CD's) must be submitted to Dr. YSR UHS through a special messenger of the college within the dates mentioned above.
10. The Principals are requested to submit the particulars of the students submitting Dissertation in the enclosed proforma annexure.
11. Kindly acknowledge receipt of this notification.
