Sub:-Dr. YSR UHS – ADMISSIONS – Mop-up Round of web based counseling for admission into BUMS Course for the Academic year – 2022-23 – Certain instructions issued - Regarding.

I am by direction to inform that, the Mop-up Round of web counselling for Competent Authority Quota seats in BUMS Course is completed and candidates have to report at the respective AYUSH Colleges on or before **3.00 PM on 02-03-2023**. College wise allotted list is placed in the University website <http://drntruhs.in>

In this connection, I am to inform you that, this University has only verified the uploaded scanned copies of the candidates for BUMS admissions. The Original certificates of the candidates were not verified by the University.

In this regard you are directed to constitute a “Committee” consisting of 2 or 3 Professors and Principal as chairman of the Committee to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately.

The “Committee” to be constituted at the colleges, shall arrange for the verification of all the Original certificates of the candidates as University has verified only the scanned and uploaded documents. Any deviation should be brought to the University notice immediately.

For BUMS Course: As per F.No.11-76/2021-BUMS (Unani-UG Regl.) dated. 28-02-2022 the following is the regulation on Eligibility for admission into BUMS course which is applicable from the academic year 2021-22.

- a. The candidate shall have passed Urdu or Arabic or Persian language as a subject in the 10<sup>th</sup> standard or in 12<sup>th</sup> standard.
- b. The candidate who is not covered under clause(b) shall have to study Urdu language along with Arabic and Mantiq Wa Falsafa (logic and Philosophy) as a subject during the First professional B.U.M.S. session.
- c. The syllabus is applicable to the students admitted in the academic year session 2021-22 onwards **5 years** or until further notification by NCISM, whichever is earlier (Ref.11-76/2020-Unai) (U.G. Syllabus) dt.29-03-2021.

**Instructions: -**

1.	The candidates who have already joined in All India Quota/Any State/Other Universities including KNR UHS, Telangana State are not eligible to participate in this counseling. If it is found that the ineligible candidate participated in this counseling, candidature of such candidate will be cancelled and will not be permitted in further counselings.
2.	<b>The candidates who were allotted seat in 1<sup>st</sup> &amp; 2<sup>nd</sup> Phase counselling are not eligible in this Mop-Up Round counselling.</b>
3.	The candidates are instructed to visit the website: <a href="http://ugcq.ntruhsadmissions.com">http://ugcq.ntruhsadmissions.com</a> for status of allotment.
4.	The selected candidates can download the provisional allotment order on payment of University Registration Fee through payment gateway and report to the Principal of the allotted college on or before the date specified in the allotment order.
5.	<b>UNIVERSITY FEE:</b> Candidates to whom allotment message is given have to pay <b>Rs.8600/-</b> before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking).
6.	<b>TUITION FEE:</b> <b>1. Govt. Colleges:</b> Fee as fixed by the Govt. of Andhra Pradesh. <b>2.Private Colleges:</b> The selected candidates have to pay tuition fee of Rs.22,000/- per year for admission into AYUSH Courses as per orders of Government of Andhra Pradesh G.O.Ms.No.159 HM& FW (C2) Dept., dt.23.12.2020 & G.O.Ms.No.14 HM& FW (C1) Dept., dt.09.02.2021.
7.	The University fee and other fee once paid shall not be refunded under any circumstance.
8.	Classes have already Commenced from <b>20-02-2023</b> .
9.	The selected candidates have to submit all the original certificates, pay the Tuition fee, and complete the process of admission. If the candidate does not fulfil the above criteria to complete the admission process as per the specified dates of admission, their admission will be cancelled automatically.
10.	After the cutoff date for reporting i.e., by <b>3.00 PM on 02-03-2023</b> , no candidate should be admitted and their Provisional admission is deemed to be cancelled without any further intimation.
11.	No candidate is permitted to withdraw from the course.
12.	Principals have to upload the Reported/Not Reported data in the Website <a href="https://ug.ntruhsadmissions.com/principal_logion/">https://ug.ntruhsadmissions.com/principal_logion/</a> by <b>5.00 PM on 02-03-2023</b> .
