In continuation to this Office notifications dt. 25.10.2022 & 11.11.2022, Dr. YSR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for Phase-II of counselling for admissions into Management (category B1, B2 & category C (NRI)) Quota seats of MBBS course under Dr. YSR UHS for the academic year 2022-23:

All the candidates whose names are present in the Final Merit Position of Management Quota displayed on 11.11.2022 and in Addendum in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website <http://ntruhs.ap.nic.in>

University Fee:

The selected candidates have to download the allotment order by paying the following University fee through Payment Gateway by using online payment method. (Debit Card / Credit Card / Internet Banking/UPI) and report to the Principal of allotted college along with the allotment order and original certificates before the date specified in the allotment order and pay the prescribed tuition fee at college.

NOTE : Candidates those who allotted in the Phase-I under Management Quota and paid university fee need not pay again.

Tuition Fee:

As per G.O.Ms.No.146 HM & FW, (C1) Department Dt.05-11-2020, the following is the tuition fee in respect of the Category-B & C seats in Private Un-aided Non-Minority and Minority Medical Colleges in Andhra Pradesh per annum for 4 ½ years.

Instructions to the Candidates:-

1. As per the orders dated.22.07.2022 of the Hon'ble Supreme Court of India in Contempt Petition (C) No.289 of 2022 and as per the Notice 12021/01/2022-MEC, dt.12-07-2022 of DGHS, Ministry of Health & Family Welfare, Govt. of India, New Delhi, the joined candidates up to round 2 of AIQ or State Quota shall not be eligible to participate in the further rounds for All India Quota or for State Quota from the academic year 2022-23 onwards.
2. The candidates who have joined in MBBS Course under Management Quota in earlier counsellings of Dr. YSRUHS are also eligible for exercising options in this 2nd Phase of counselling, if they wish to slide to other college or to another category. The candidates are also eligible to slide from category 'C' to category 'B'.
3. **The candidate has not joined/reported in the allotted seat of Phase-I under Management Quota, then that particular seat will not be available for that candidate to exercise web options in this 2nd Phase of counselling.**
4. The candidates who have not reported at the allotted college in the 1st phase counselling under Management Quota, will be allowed to participate in the 2nd Phase counselling.
5. Candidates who have been allotted seat in any phase of Management Quota counselling are not eligible for Mop-up round counselling.
6. Candidates are advised to go through the prospectus for the regulations of Dr. YSR UHS available on website before exercising web options.
7. The number of seats available under Management Quota Category B1, B2 & Category C (NRI) in Private Unaided Non-Minority and Minority Medical Colleges is given at Annexure-I.
8. The allotments will be as per the prioritised options exercised by the candidates.
9. The selected candidates for MBBS course in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati have to pay the tuition fee at the respective college at the time of admission. Visit SVIMS Website <http://svimstpt.ap.nic.in> for details of tuition fee and other fee particulars.
10. **Options:**
 - a. The eligible candidates present in the Provisional Final Merit list displayed on 11.11.2022 and in Addendum under Management Quota should exercise options.
 - b. A candidate has to exercise options for the interested medical colleges in the order of priority.
 - c. Candidates are instructed to be careful while exercising options on the web. One Time Password will be sent to the registered mobile and mail at the time of entering and submitting web options.
 - d. The options once exercised are final. No request for change of options or order of college priorities will be entertained after closure of above said web options schedule.
 - e. Candidates are instructed to take the print out of the saved options.
11. Management Quota B & C (NRI) seats in Minority Medical Colleges will be allotted to Muslim Minority Candidates only. If Muslim Minority Candidates are not available, the seats will be allotted to Non-Muslim Minority Candidates in the Mop- up Phase of Counselling. Muslim Minority Candidates are also eligible for Management Quota seats in other Medical Colleges.
12. Candidates have to exercise options for B category and if eligible for C Category (NRI) in order of priority of the colleges. Allotments will be made according to the order of preference in the web options exercised by the candidate and as per rules.
13. Candidates will receive the message regarding allotment of seat, if seat is allotted.

14. Candidates are hereby informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action will be initiated as per University Regulations.
15. Selected candidates have to report to the Principal of the allotted college before the last date and time for joining as specified on the allotment letter with all original certificates and relevant bonds, if any, and pay the tuition fee and college fee to complete the process of admission. If the candidate fails to report before the reporting date and time, the admission will be cancelled automatically.
16. If the joined candidate of Phase-I slides to other college during 2nd phase of counselling, the original certificates will be sent to the newly allotted college by the previous college after closure of admissions. The candidate has to report at the re-allotted college with downloaded allotment order along with custodian certificate issued by the previous college and to pay the tuition fee to complete the admission process, failing which the candidate will forfeit the admission.
17. Candidates allotted seat under NRI Quota should produce the relevant sponsorship letter from NRI relative in Original along with copy of passport/ Residence Proof/Bank Statement or pass book of sponsor for NRI Category at respective colleges.
18. **Next phase for Mop-up counselling (exercising web options) will be conducted for:**
 - a. Unfilled seats in Phase – 2.
 - b. Not reported / Not joined seats after Phase-2.
19. If a candidate is allotted a seat in MBBS course as per his/her options and does not join the course, he/she will not be eligible for that course in Mop-up phase of counseling to prevent seat blocking.
20. The University fee once paid shall not be refunded under any circumstances.
21. As per G.O.Ms.No.72, HM&FW (C1) Dept., dt.15-07-2019, if any candidate wants to withdraw from the course after the closure of admissions, in the middle of the course such candidate has to submit his/her request through the Principal of the college concerned along with course discontinuation fee of Rs.3,00,000/- for MBBS plus GST as applicable to the University by way of demand draft drawn in favour of the Registrar, Dr. YSR University of Health Sciences, payable at Vijayawada.
Note: The requests received directly from the candidates for withdrawal from MBBS course will not be entertained under any circumstances. Any request shall be routed through Principal concerned only as per the G.O.Ms.No.72, HM & FW (C1) Dept, dated.15-07-2019.
22. Decision of Competent Authority is final.
23. Dr. YSR University of Health Sciences does not entertain or support seat blocking/ cancellation of MBBS seats.
24. In case any student is found involved in seat blocking, legal action will be initiated against such candidate as per rules.
