**Admission into MS (Obstertrics&Gynaecology) – S2 (NRI) seat of the Academic year 2021-22 in Alluri Sitarama Raju Academy of Medical Sciences, Eluru**

In obedience to the Orders, dt.28-10-2022 of Hon'ble High Court of Andhra Pradesh in W.P.No.33391 of 2022, application forms in the prescribed format (Annexure) are invited from the eligible candidates whose names are present in the PG(Medical) Management Quota Merit list(MQ) and opted S2 (NRI) seat of the academic year 2021-22 for admission into MS (Obstertrics&Gynaecology) – S2 (NRI) seat of the Academic year 2021-22 in Alluri Sitarama Raju Academy of Medical Sciences, Eluru subject to the Final outcome of the Writ Petition.

The name of the candidate applying now should be present in 2021-22 MQ Merit list with S2 option and should not have joined and continuing any where in any PG(Medical) seat to be eligible for admission into said MS (Obstertrics&Gynaecology) – S2 (NRI) seat as per rules.

Tuition Fee as per G.O.Ms.No.56, HM & FW (C1) Department, dt. 29-05-2020 of Government of Andhra Pradesh is Rs.50,00,000/- (Rupees fifty lakhs only) per annum

Note: The fee structure in Private Unaided Non-Minority Colleges is as per G.O.Ms.No.56, HM&FW (C1) Dept., Dt.29-05.2020 as per the directions of the Hon'ble High Court in W.P.No.10159 of 2020 and batch, dt.09-07-2020, which is read as "to permit the petitioners/students to pay fee fixed by the Regulatory authority by executing bond in the proforma prescribed by the Andhra Pradesh Private Medical and Dental Colleges Managements Association within the specified time as notified by Dr. YSR University of Health Sciences, Vijayawada".
